- The following are important excerpts from the By-laws and Rules of Fairport Harbor Yacht Club;
- 1 I must attend at least (3) general membership meeting per year.
 - 2 I understand that as an associate member, I have no voting, docking, or ram privileges. As a Full Member my boat must meet the dimensional requirements.
 - 3 The club does not guarantee water depth at any dock. It is the members responsibility to determine if the water space is suitable prior to dock day bidding.
 - 4 I am obligated for forty (40) work party hours annually or pay a fine for every hour less than 40.
 - a. Twenty (20) hours must be put in to remain a member in good standing. The following exceptions apply;
 - i. If excused by the Board of Directors
 - ii. Prorated based on month of entry.
 - 5 Club House Clean-Up and Night Watch
 - a. Schedule appears on bulletin board, each member is usually scheduled 2 or 3 times per year.
 - b. Hours are from 7PM to 9PM;
 - c. You must sign the roster when work is completed;
 - d. Two (2) work party hours are credited per Night Watch.
